ENOTHE Projects

Updated guidelines for the Application 2019





General Information

ENOTHE supports and promotes collaboration between European Occupational Therapy educational members and relevant stakeholders by supporting the establishment of project groups.

The ENOTHE board set aside a certain percentage of the annual budget for seed funding project groups each year. The amount of project groups would have to be approved by the General Assembly each year. The number of projects will be determined by the amount of funding available.

The applications are to be assessed in a first phase (pre-trajectory) by a specially appointed review panel from OT Europe Register of Experts. Applicants will receive feedback from the panel after which applicants can adapt and resubmit proposals for a second round. Recipients of the ENOTHE projects funding will be presented during the Annual Meetings. Projects can start for the duration of maximum two years. After this period the project is expected to continue developing through other sources and findings e.g. Erasmus resources.

Since applications are reviewed by an international expert group, your application should be written in English.

Focus areas

Applicants shall contribute to advance and promote knowledge and collaboration in relation the aims and areas of the **ENOTHE Strategy 2016-2020** (link) and/or development of educational goals between European institutions/stakeholders. In particular, projects shall directly benefits ENOTHE members and strategic stakeholders.

ENOTHE projects are projects run by ENOTHE groups (at least 3 partners who are member of ENOTHE) focussing on projects with a clear implication on education. It has to be clear why ENOTHE members need the project and what their benefit is.

So far ENOTHE board identified that the following examples of possible topics/ aims to be covered:

International Connection Sustainability of members in ENOTHE Association; inclusiveness of ENOTHE

Capacity building; building ENOTHE Academy

Inter-professional Education

Involve student engagement; developing Student Programs aligning annual meetings


Conditions to apply

Relevance and utilisation:

- \bullet The project's relevance for ENOTHE's Strategy 2016-2020 and educational needs in the European context
- Engagement of users during the development of the project
- Utilisation and dissemination of the project results

Feasibility of the planned project:

- The project group's competence for carrying out the planned project
- Budget, assessed based on reasonableness
- Collaboration with relevant users and/or stakeholders
