## **Cookie Law**

This website is owned and operated by the European Network of Occupational Therapy in Higher Education (ENOTHE), a non-governmental organisation registered under Austrian Law. The organisation's address is Holmeistergasse 7 9 /2/1, A- 1210, Austria.

The EU has passed a "Cookie Law" which says websites must display a "Message" to its users warning them that the website they are viewing uses "Cookies" or small bits of text which are stored on your computers when you visit a website.

Basically, most websites use cookies and this website is no different. As this website has adverts, the cookies stored on your computer from this website relate to the Google advertisements displayed on this website.

We also use Google analytics to track the hits on this website. If you send us messages from our website, leave comments or register as a user another cookie will be issued in case you decide to come back again.

If you don't agree with our cookie policy then please leave now or put your comment below, but this will leave a cookie on your computer!

If you don't want to accept cookies from the website most modern browsers allow you to reject cookies but some website functionality maybe impaired if you reject cookies from our website.

## **What are cookies?**

Cookies are small encrypted text files that are stored on your device by a website. [www.enothe.eu](http://www.enothe.eu) uses cookies to enable you to shop, enhance your shopping experience and to analyse our traffic.

We also share information about your use of our site with third parties for social media, advertising and analytics and these third parties may combine it with other information that you've provided to them or that they've collected from your use of their services.



## What are cookies used for? Understanding cookies

Cookies can be classified into the following categories

**First-party cookies** – these are issued from the website you have accessed. These cookies often serve to give memory to the website about your data and preferences.

**Session cookies** – these are used during a browser session. They may be used for a variety of purposes such as remembering what you have put in your shopping basket as you browse around our website. These session cookies will expire after a browser session.

**Third-party cookies** – these are cookies that are set by a website other than the one you are on. If you visit a website and a separate company sets a cookie through that website this would be a third-party cookie.

**Persistent cookies** – these are stored on a device in between browser sessions which allows your preferences or actions across our website (or in some cases across different websites) to be remembered. Persistent cookies may be used for a variety of purposes including remembering users' preferences and choices when using a site or to target advertising.

## Our cookies

We don't store personal information in the cookies we create, but personal information that we store about you may be linked to the information stored in and obtained from cookies.



Our cookies can be split into 3 types:

- **Essential cookies**

These cookies (first-party cookies) provide the functionality on our site to allow you to shop. This includes adding products to your bag and allowing us to remember what products you've added to your bag. Without these cookies, you will be unable to use the [www.enothe.eu](http://www.enothe.eu) site.

- **Performance cookies**

These cookies (session cookies) allow us to review how you use the brittanyclub.co.uk website, so that we can measure and improve performance. It is in our legitimate business interests to use these types of cookies but you can restrict these at any time. Without these cookies the site may not perform or look as expected.

- **Advertising and Targeting cookies**

We do not currently use this type of cookie but may do in the future.

## **Manage cookies**

Some cookies are essential in order for us to use the on-line shop functionality on our website and in the event you do reject cookies this may impair the functionality of the Website meaning that you are unable to shop at [www.enothe.eu](http://www.enothe.eu)

You can choose which cookies you'd like to store on your device by updating your browser settings. Each browser allows you to restrict or block cookies in different ways.
