Dear members of ENOTHE,

We still look back at a successful Annual Meeting in Zagreb organised by Saša Radić, president of the Croatian Association of Occupational Therapists and her team together, with the ENOTHE office and members of the ENOTHE board. This was in collaboration with the staff and students of the local University. A great deal of effort was put in to making Occupational Therapy visible and valued in Croatia and other European Countries.

Saša was able to attract many sponsors making this event and social dinner available for all attendees. Apart from the excellent content of the keynote speakers and workshops, we were impressed by the choir and dancers.





This year the organisation of the General Assembly was challenging because of the amount of items that had to be addressed e.g. the proposal to create an official association with a registered constitution. On behalf of the board, Johanna Stadler-Grillmaier continues to be

making progress and it is expected that the association will be established in January 2018. The ENOTHE bank account can then be opened in Austria.

One vacancy in the board was fulfilled by the re-election of Marie-Antoinette Minis.

A challenge is to fulfil the vacancy of the office. York St John University has decided to end the service level agreement with ENOTHE. Meanwhile a solution is in sight.

#OTPOWER: BREAKING THE BARRIERS

This is a collaborative project carried out by students of Occupational Therapy from Portugal, Spain, Armenia and Georgia and aims to promote occupational therapy among the population of the participating countries, raise awareness of the role that an occupational therapist can have in social inclusion – through realising which are the specific needs and realities of each country – and share values and knowledge among OT Power students.

We focus on the idea that the person is the expert in his health process and the role of the Occupational Therapist is centred in accompanying, advising and making an active listening.

Based on a common activity made with the participation of people from each country, we had the opportunity to develop a workshop at the ENOTHE – Zagreb for the students, and then present our project to everyone at the conference.

We considered this a high point of our participation in the congress given the richness of the debate that arose not only for us, but for all those present – this was a great moment of sharing opinions and experiences. Some relevant questions arose: Are there limits in our practice? Which are the different job opportunities in each country? What are the main areas of intervention? Which are the different perspectives about different working fields?

At the end of the three days, the feeling was not only of realisation and satisfaction due to the effort and work done, but also due to the feedback from the participants, who conveyed a great interest, concern and willingness to do more about this topic.

We recommend all students to get involved in this type of projects because the dissemination and development of occupational therapy depends on each one of us and it is very important to be aware of it in our daily lives.

MINIMUM STANDARDS FOR THE EDUCATION OF OCCUPATIONAL THERAPISTS REVISED 2016

During the Annual Meeting Yara Peterko kindly stepped in to share her knowledge about the WFOT Minimum Standards of Occupational Therapy Education.



During the ENOTHE Annual Meeting I had the opportunity to answer some of your questions regarding the WFOT and the minimum standards. As the ENOTHE Board thought this could be interesting to all of you, this short summary includes the main topics, that have been discussed in Zagreb after the WFOT Power Point Presentation.

Occupational Therapy is a rather young profession that has gone through paradigm shifts during the last decades and has developed over the years. More and more countries are offering educational programmes. By this year the WFOT has 67 full members, that means 67 different countries offer programmes to train future Occupational Therapists in WFOT approved programmes.

To ensure that the students graduate with the same competences and have the same understanding about Occupational Therapy, the WFOT developed Minimum Standards for the Education of Occupational Therapists. These standards were revised in 2016 and a digital copy has been shared with the member countries in September 2016.

The member organisation has permission to circulate the document to WFOT approved education institutions/universities and the WFOT requested them to do so.

ROTOS REPORT – DECEMBER 2017

In the last 12 months the third 'leg' of OT-Europe, with the support of ENOTHE and COTEC has made big progress. During the year a standing ROTOS committee was established:

The ROTOS Standing Committee had the first face to face meeting in London on June 2017 and the second will be on January 2018.



The aim is to meet twice a year once when OT-EU meets at either the ENOTHE Annual Meeting or COTEC General Assembly. Regular Skype meetings took place during 2017 and will take place in between the face to face meetings in 2018.

The initial funding of ROTOS is shared equally between COTEC and ENOTHE with the approval of the two AGMs with the aim that ROTOS will become self-sufficient over time.

The main aim of ROTOS is to establish a strong European Network of OT and OS researchers that both support access to occupation-based knowledge for all EU citizens, and strengthens the occupation-based knowledge generation. With this perspective the standing committee took the following actions in order to build partnerships to populate ROTOS and develop a common understanding with key stakeholders:

- A presentation of a workshop at the Occupational Science conference 8-9th September in Germany.
- A launch workshop at COTEC governance day in Vienna for the national members of COTEC
 30th of September in Vienna.
- A launch workshop at ENOTHE conference in Zagreb, Croatia 26th-28th October.

During 2018 the standing committee will inform both ENOTHE and COTEC members for any developments and the ROTOS website will updated with news and information.




EVALUATION OF THE 23RD ANNUAL MEETING 2017
