# HANNEKE VAN BRUGGEN LECTURE NOMINATION INFORMATION

The Hanneke van Bruggen Lecture was created at the 16th Annual ENOTHE 2010 Meeting at Stockholm, Sweden, in honour of Hanneke Van Bruggen then, the outgoing Director of ENOTHE. In creating the Hanneke van Bruggen Lecture, the ENOTHE board wished to recognise and honour Hanneke Van Bruggen for her unending dedication and outstanding work in promoting the development of occupational therapy higher education programmes in Europe and internationally.

The Hanneke van Bruggen Lecture is held once a year during the ENOTHE Annual Meeting and is awarded to an Occupational Therapist working in Europe.

Other professionals that advocate the Occupational Therapy legacy and values are more than welcome to be invited for this honour.

# Regulations

- The candidate (nominee) has to be nominated by at least two (2) ENOTHE member institutes (nominators: proposer and seconder);
- The nominee has to agree that he/she is willing to be nominated;
- The proposed lecture should address at least some of the decision criteria;
- Only nominations with all supporting documentation are considered;
- Nominations sent outside the specificied time period will not be considered.



#### **Decision Criteria**

The ENOTHE Board will use the following criteria to decide upon the Hanneke van Bruggen lecturer nominations:

- Focus on and impact for Occupational Therapy;
- The European perspective;
- Diversity in local, national or international context;
- Span over the triad of education, practice and research;
- The relevance to society;
- Innovation in occupational therapy education or occupational science.

### **Accepted nominee compensation**

Travel expenses and two nights of accommodation will be paid by ENOTHE.

It is strongly advised that flights and/or trains are booked well in advance in order to secure the best deals available.

# **Guidelines/Steps to nomination:**

- Contact the proposed nominee to make sure that the nomination is agreed upon;
- 2. Colect the detailed Curriculum Vitae of the nominee.

The curriculum vitae should cover the following areas (as appropriate): Professional Qualifications (Occupational Therapy) attained or currently being undertaken, Other Qualifications, Work Experience, Professional Interests/International Interests, Other skills and experience like presentation skills;



- 3. Written statement (max. 300 words) by the nominators in support of the nomination, giving reasons why the nominee deserves the honour of giving the Hanneke van Bruggen Lecture.
- 4. Complete the nomination form: fill and sign
