Abstract: Georgia is a country at the intersection of Eastern Europe and Western Asia. It is part of the South Caucasus, bounded by the Black Sea to the west, by Russia to the north and east, by Turkey to the southwest, by Armenia to the south, and by Azerbaijan to the southeast. The country covers an area of 69,700 square kilometres (more than 20% of which is occupied by Russia) and has a population of 3.7 million people. Tbilisi is its capital as well as its largest city, home to roughly a third of the Georgian population.

In 2002 the first education for occupational therapy teachers started and in 2003 a TEMPUS project to co-create the profession and the education in Armenia and Georgia together with ENOTHE had been approved by the European Commission. At the moment there is one occupational therapy programme at Ivane Javakhishvili Tbilisi State University with 12 teachers in occupational therapy and 43 students. There are 40 practicing occupational therapists out of a total of 44graduates.

In the presentation we will go with you on the journey of the development of occupational therapy (education) during the past 20 years. We will start with some facts and figures and the cultural, socio, economic and historical background of Georgia, but we like above all to discuss with you the dilemmas and choices, the cultural gifts and conflicts in this process of development and our personal dialogues and experiences.

We will round up with a vision for the future and with many questions for the audience. We are looking forward to your participation in this journey.
